Arts and Birla Commerce Mahavidyalaya, Dhamangaon Rly., District Amravati established in 1961 us of UGC Act 1956 (2f & 12B) having its office at Anjansingi Road, Dhamangaon Rly., District Amravati, Maharashtra-444 709 represented by Principal referred herein after as (Party-A)

And

Vidya Prasarak Mandal's, Amolkakchand Mahavidyalaya, Yavatmal established in 1956 us of UGCAct1956 (2f & 12B) having its office at Godhani Road, Yavatmal, Maharashtra-445001 represented by Principal referred herein after as (Party-B).

Adarsha Science, J. B. Arts and Birla Commerce Mahavidyalayaand *Amolakchand Mahavidyalaya*, *Yavatmal* hereinafter referred to jointly as "the Parties," do hereby agree on the following:

WHEREAS Adarsha Science, J. B. Arts and Birla Commerce Mahavidyalaya was established in the year 1961under the aegis of Dhamangaon Education Society, Dhamangaon Rly. with the faculties of Arts and Commerce, the college has added Science faculty in the year 1972 and today boasts of a total strength of about 2500 students studying at Junior College, Undergraduate and Post-graduate levels. There are separate classroom buildings for the Arts, Commerce, Science. The college has well established laboratories with University Recognized Research Centers in Physics, Zoology, Mathematics, Microbiology, Electronics, Economics and Commerce.

WHEREASAMV was started in MOR BHAWAN of town with 40 students only in academic session 1956-57. The college was affiliated to Nagpur University, Nagpur. The college was blessed by Pandit Jawaharlal Nehru, the first Prime Minister of India & he inaugurated the Science faculty of the college on 18th April 1959. Now college has a well-established building, laboratories, Library, Playground spread over 39 acres of land. The college is providing education to students of HSSC, Graduate and Post Graduation in Arts, Commerce, and Science. The college has university-recognized research centers in Physics, Electronics, Chemistry, Zoology, and Computer Science. The college is presently affiliated with Sant Gadge Baba Amravati University, Amravati since 1983. The golden jubilee of the college was celebrated with the auspicious blessings of his Excellency Dr. A.P.J. Abdul Kalam, Hon'ble President of India & His Bhairosingji Shri. Shekhawat, Hob'ble Vice-President India.(PARTY B)

AND WHEREAS both the Institutions are interested to have an inter-institutional tieup with the objective to enhance the quality of teaching and learning process, research, and extension of services by undertaking mutually accepted collaborative activities in the areas of their core competence

NOW, THEREFORE, IN CONSIDERATION OF THE PREMISES AND MUTUAL COVENANTS HEREINAFTER CONTAINED, THE PARTIES HERETO AGREE AS FOLLOWS: -

I - OBJECTIVES

The objective of this Memorandum of Understanding (MoU) is to promote mutual cooperation in education and training on a reciprocal basis, for the advancement of knowledge and intellectual development.

II - SCOPE OF COOPERATION

Adarsha Science, J. B. Arts and Birla Commerce Mahavidyalayaand *Amolakchand Mahavidyalaya*will:

- 1. Facilitate the exchange of faculty experts, researchers, academic personnel, and students.
- 2. Facilitate short semester visits for students in either institution.
- 3. Support joint research by faculty members and/or researchers from parties, which can be funded by institutions, the private sector, and/or government agencies/departments.
- 4. Support teaching and learning activities through visiting lecturing activities in both parties concerned.
- 5. Facilitate academic staff development programs.
- 6. Organizing and participating in Joint Symposia / Conferences / Workshops / Short-term Refresher Courses and other activities related to the objectives of this MoU.
- 7. Consider any other collaborative efforts that both parties may deem fit.

III – IMPLEMENTATION

The Parties shall implement the MoU through specific arrangements, programs, and/or projects subject to the available funds of the Parties.

IV - ACADEMIC PROGRAMS

Both parties concerned will retain control and authority on academic matters or business/industry code of conduct in their respective degree, diploma programs, and positions in business/industrial institutions. However, amendments and customizations of MoU to meet regulatory compliance shall be done with the mutual consent of the two parties involved.

V – FUNDING

This MoU, being a co-operative and collaborative understanding for academic excellence and enhancement of quality research activities, shall not create any financial and or legal commitment whatsoever on either of the parties hereto, except as may be provided in activity-specific agreement(s) that may be entered into subsequently.

VI - PUBLICATION

Publications, if any, in respect of the activity under this MoU shall be in the name of the personnel involved from both parties. In all publications (papers, reports, etc.,) it will be duly acknowledged that the work has been carried out by Adarsha Science, J. B. Arts and Birla Commerce MahavidyalayaandAmolkakchand Mahavidyalaya, Yavatmal under this MoU between the parties.

VII - CONFIDENTIALITY AND INTELLECTUAL PROPERTY RIGHTS

- 1. Both parties hereunder agree that any information disclosed by one party to the other under this MoU shall be maintained as proprietary confidential information and that such information will be disclosed only to the authorities as required in the relevant statutory regulations. All such proprietary confidential information will be kept in confidence and the party receiving the confidential information agrees to prevent disclosure to any other person(s) except to the personnel authorized by either of the parties on the need-to-know basis for the execution of work under this MoU.
- 2. In case of any specific arrangement, program, or project that may result in intellectual property rights, the Parties shall enter into a separate agreement in accordance with the laws and regulations.

VIII.CO-ORDINATION

Each institution shall appoint one member of its teaching faculty to coordinate the programs on its behalf.

The coordinators will periodically review and identify ways to strengthen cooperation between the two institutions.

IX - SETTLEMENT OF DISPUTES

Any dispute arising from the implementation of the provisions of this MoU shall be settled amicably by consultations or negotiations, failing which the matter shall be referred to and settled through arbitration. The arbitration proceedings shall be held in accordance with the provision of the Indian Arbitration and Reconciliation Act, 1996, and subsequent acts. The venue of arbitration shall be Dhamangaon Rly. and the Language of arbitration shall be English.

X – AMENDMENT

This MoU may be reviewed and amended at any time, by mutual written consent of the Parties.

XI - NOTICES

All notices required to be served under the terms of this MoU, shall be in writing and considered to be duly served, if the same is delivered either in person by obtaining acknowledgment or posted by registered mail, addressed to the Registrar of the Institution concerned or at the latest address notified to the other Party herein.

XII - DURATION AND TERMINATION

- 1. This MoU shall be effective for a period of three (3) years from the date of signature by both Parties.
- 2. This MoU may be terminated at any point of time, by either party, by issuing a ONE-month notice, in writing, to the other party prior to the desired date of termination. The termination of this MoU shall not affect the validity and duration of any arrangements, programs, activities, or projects made under this MoU until the completion of such arrangements, programs, activities, or projects unless otherwise agreed upon by the Parties.
